Corrigendum 4 to Version 2.1.4

This Corrigendum notice identifies the corrections to the Parts as noted below:

Corrected Versions of the Specification may be identified by the indicator COR 4 which can be found on the title page under the ISBN Number. The last modified date in the footer of the front page will be 10th January 2011 (2011-01-10) in Part 5.

Reason for the Corrigendum:

The table that defines the TYP24Flags definitions for IFR2 of the new TYP 24 has not been implemented in the Specification consistently with other IPEs. This has been causing confusion and to resolve this, the table is reformatted to be consistent with other TYPxxFlag tables. There is no change to the content of the table however the opportunity is taken to correct a typographical error.

To resolve these issues it is therefore necessary to make the following corrections to the Specification:
